RIH w/6-1/4" bit & tagged cement @ 3675'. Drilled cement to 3765' and then drilled formation to TD @ 7818'. TD reached 11/27/00. RIH w/4-1/2" 11.6# I-80 casing(had trouble RIH, had to COOH, cut off stuck casing and then fish casing out & rerun). Finally able to set casing @ 7789'. RU to cement. Pumped 10 bbls KCl water, 20 bbls mud clean, & 10 bbls KCl. Pumped Lead-185 sx (392 cf-69.81 bbls slurry) Type 3 35:65 POZ, 6% Bentonite, 10#/sx CSE, 0.3% CD-32, 1% FL-52, 0.25#/sx Cello-flake, 5#/sx Gilsonite.

Tail - pumped 50 sx (63 cf - 11.21 bbl slurry) Class H, 0.3% FL-25, .25#/sx Cello-flake, 5#/sx Gilsonite. Displaced with 120 bbls H2O. Plug down @ 1245 hrs 12/6/00. Float held. Partial returns during cementing, but no cement to surface. ND BOP, set slips and cut off casing. RD & released rig 12/6/00.
