3/26/01. MIRU Key Energy #40. ND WH & NU BOP. PT-OK. RIH w/bit & tagged up @ 7742'. Drilled out collar and cement to 7784'. Circ. hole clean. RU Blue Jet & ran CBL/CCL/GR from 4230' to PBTD @ 7788'. Estimated TOC @ 5475'. PT casing to 500 psi for 20 minutes and 3000 psi for 10 minutes, held good. Perforated Dakota interval @ 1 spf .34" holes as follows:

7751', 7743', 7738', 7733', 7727', 7723', 7718', 7716', 7713', 7707'
7697', 7689', 7664', 7661', 7657', 7654', 7652', 7650', 7647', 7641' Total 20 holes

RIH w/packer & set @ 7675'. Broke down perfs w/2% KCL. Released packer & reset @ 7540'. Acidized perf w/1500 gal 7 1/2% HCl. Released packer & COOH. RU to frac. Pumped slick water frac w/50,600 # 20/40 Tempered LC sand & displaced w/94 bbls slickwater. Total fluid pumped 3,422 bbls. Flowed back on 1/4" and 1/2" chokes. RD flowback equipment. RIH w/2-3/8" tubing and cleaned out to PBTD @ 7788'. PU & set tubing @ 7726'. ND BOP & NU WH. PT-OK. Pumped off expendable check. RD & released rig on 4/2/01. Turned well over to production to first deliver.

Note: Plans are to squeeze cement behind casing before completing the MV intervals.
