Pumped 20 bbls FW, 10 bbls mud clean, 20 bbls FW/red dye. Pumped Lead - 465 sx (1106 cf-197 bbls slurry) Type III cement 35/65 POZ w/5#/sx Gilsonite, 1/4#/sx Cello-flake, 6% gel, 10#/sx CSE, 3% KCL, 0.4% FL-25, (2.38 yield). Pumped Tail - 50 sx (67.4 cf - 12 bbls slurry) Type III cement w/1/4#/sx Cello-flake, 1% CaCl2 (1.40 yield). Dropped plug & displaced with 153.7 bbls FW. Plug down @ 1549 hr 7/8/00. No cement or red dye to surface.

ND BOP, set slips and cut off 7" casing. NU WH & BOP. PT-BOPs, manifold and casing and blind rams to 3000 # 10 minutes. Good test. Ran temperature survey. TOC-700'.
