Pumped 10 bbls mud clean, 20 bbls water spacer w/red dye ahead of 165 sx (233 cf - 41.5 bbl slurry) Type 3 cement w/2% CaCl2, 1/4#/sx Cello-flake. Dropped wood plug and displaced with 22.7 bbls FW. Left 30' cement in casing. No cement to surface, but had red dye. Shut down & fluid fell down hole. WOC. Top set 9-5/8" casing w/100 sx cement w/2% CaCl2. Cement to surface. WOC. Break out landing Jt. NU WH & BOP, lines and manifold. PT casing and rams to 200 # 3 minutes and 1500 psi, 10 minutes. Good test.
