Flowed back on 1/4" and 1/2" chokes. RD flowback equipment. RIH w/2-3/8" tubing and cleaned out to PBDT @ 8008'. PUH & landed tubing @ 7913' with "F" nipple set @ 7881'. ND BOP & NU WH. Pumped off exp. check. RD & released rig 2/20/01. Turned well over to production to first deliver.
