



Pumped a preflush of 10 bbls mud clean & 10 bbls dye water ahead of 200 sx (282 cf - 50.22 bbl slurry) Type 3, 2% CaCl₂, 1/4#/sx Cello-flake. Displaced w/25 bbls H₂O. Plug down @ 0040 hrs 2/3/02. Circ. 15 bbls cement to surface. NU WH & NU BOP. PT frams, lines and manifold - OK. RIH w/bit & PT casing and pipe rams to 200 psi low and 1500 psi high. Good test.
