Pumped a preflush of 10 bbls H2O, 10 bbls mud clean and 10 bbls dye water ahead of Lead cement - 440 sx (1047 cf - 186.46 bbl slurry) Type 3, 35:65 POZ, 6% Bentonite, 5#/sx Gilsontite, 10#/sx CSE, 3% KCL, 0.25#/sx Cello-flake, 0.4% FL-25, 0.02#/sx Static Free. Tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl2, 0.25#/sx Cello-flake. Displaced with 137.5 bbls H2O. Plug down @ 0445 hrs 5/17/01. Circ. 20 bbls cement to surface.

ND BOP, set slips and cut off casing. NU BOP, manifold and lines. PT BOP, lines and manifold and casing to 200 psi low and 1500 psi high. Good test.
