Circ. hole. RD CUDD. RU Blue Jet & ran GR/CCL/CBL - TOC @ 2600'. Ran GSL. PT casing to 4000 psi - 10 min. Good test.

Perforated Pt Lookout @ 1 spf .34" holes @ 5493', 5465', 5448', 5427', 5414', 5399'. Then perf'd Menefee & Cliffhouse -5389', 5375', 5365', 5355', 5264', 5129', 5113', 5037', 5015', 4991', 4969', 4955', 4907'. Total 19 holes.

Acidized perfs w/1500 gal 15% HCl. RU to frac. Pumped 148,680 gal 70 quality N2 20# Linear gel foam w/75,680# 20/40 sand & 1628 mscf N2. Flowed back on 1/4" and 1/2" chokes. RD flow back equipment. NU WH. Turned well over to production department 6/8/01.

Plans are to flow test this well, return and run tubing within 60 days.
