Tail - 20 sx (38 cf - 6.76 bbl slurry) Type 3 35:65 POZ L, 5% Bentonite, 5#/sx Pheno-seal, 0.2% CD-32, 0.75% FL-52, 1#/sx Gilsonite, 0.25#/sx Cello-flake, 10#/sx CSE, 0.02#/sx Static Free. Displaced w/89.5 bbls H2O. Plug down @ 2240 hrs 6/16/01.
