

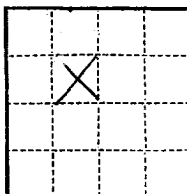

DETAILS OF WORK

It is proposed to drill this well in the following manner:

Drill 11" hole to approximately 200 feet and cement 8-5/8" casing with 125 sx. regular 4% gel cement, calculated to circulate. Drill 6-3/4" hole to total depth of 3800 feet. The Disti sand will be cored and if commercial production is indicated, 5-1/2" casing to be cemented at total depth with 100 sx. regular 4% gel cement, and 100 sx. regular cement with 90 gallons latex added. Perforate, treat and complete, using 2" EUE tubing.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

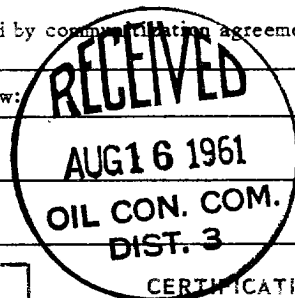

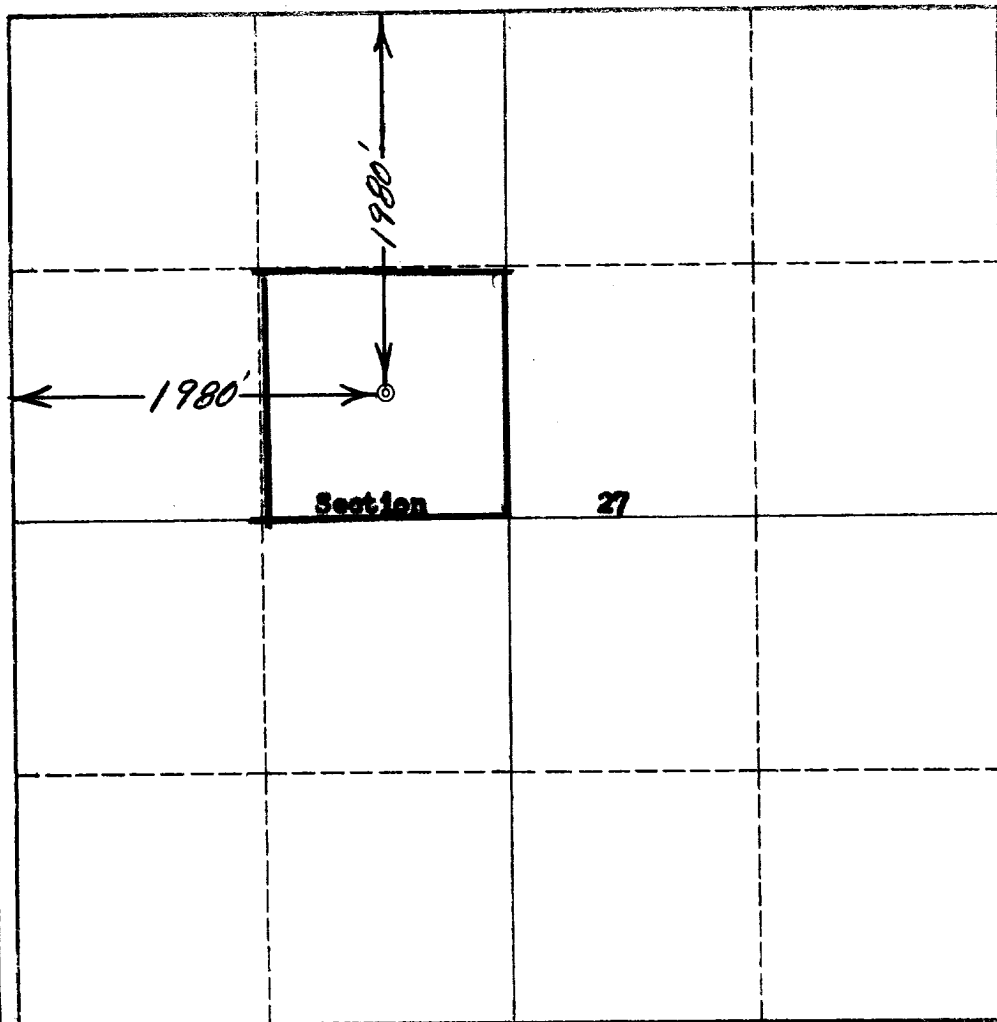

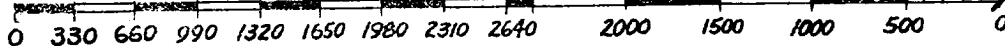
