The log log paper used for plotting the back pressure curve shall be of at least three inch cycles.

- $P_c$  72 hour wellhead shut-in casing (or tubing) pressure whichever is greater. psia
- $P_{\mathbf{w}}$  Static wellhead working pressure as determined at the end of flow period. (Casing if flowing thru tubing, tubing if flowing thru casing.) psia
- $P_t$  Flowing wellhead pressure (tubing if flowing through tubing, casing if flowing through casing.) psia
- Pf Meter pressure, psia.
- hw Differential meter pressure, inches water.
- $F_g$  Gravity correction factor.
- $F_t$  Flowing temperature correction factor.
- Fpv Supercompressability factor.
- n I Slope of back pressure curve.
