**13. Describe Proposed or Completed Operations**

It is intended to perforate and fracture stimulate the the following intervals of the Mesa Verde group. These zones were bypassed during original completion and are all located below the Huerfanito Bentonite @ 3332'. The tubing will be pulled from the well. A bridge plug will be set @ 5550' above the Point Lookout. Selected intervals from 5195-5489' will be perforated and fracture stimulated through tubing and a packer. A bridge plug will be set @ 4810'. Selected intervals from 4258-4792' will be perforated and fracture stimulated. The bridge plugs will be retrieved from the well, the tubing will be run back in the well, and the will returned to production.
