- 1 - Ran 61 joints (2490 ft) of 5 1/2", J-55, 15.5# csg. as a liner, top liner 3131 R.K.B. Bottom liner 5620 R.K.B. Cemented with 275 sacks regular cement with 4% gel on May 5, 1958, ran temperature survey top cement 3131 R.K.B.
- 2 - Cleaned out hole to 5576 on May 6, 1958 - pressured up csg. to 1800 psi - pressure held.
- 3 - Perf. 5380-5480 Sand water frac. w/100,000# sand and 90,720 gallons water Set Magnesium Bridge plug at 5300 - Perf. 5276-5246, 5224-5210, 5175-5160, 5056-4960 sand water frac. w/75,000 #sand and 110,000 gallons water.
- 4 - Drilled Bridge plug and cleaned out to P.B.T.D. of 5576.
- 5 - Ran 177 joints 2" tbg. landed at 5480 R.K.B.
