This is a request for administrative approval for an unorthodox gas well location in the Basin Dakota pool.

It is intended to locate the El Paso Natural Gas Company's San Juan 29-7 Unit #70A at 1920' from the North line and 1450' from the West line of Section 35, T-29-N, R-7-W, Rio Arriba County, New Mexico.

Topography reasons make it impossible to build a standard gas well location.

El Paso operates all proration units offsetting the proposed unorthodox location.

Plats showing the proposed well location and the terrain of Section 35, along with an ownership plat, are attached.

A 3000 psi WP and 6000 psi test double gate preventer equipped with blind and pipe rams will be used for blow out prevention on this well.

This gas is dedicated.

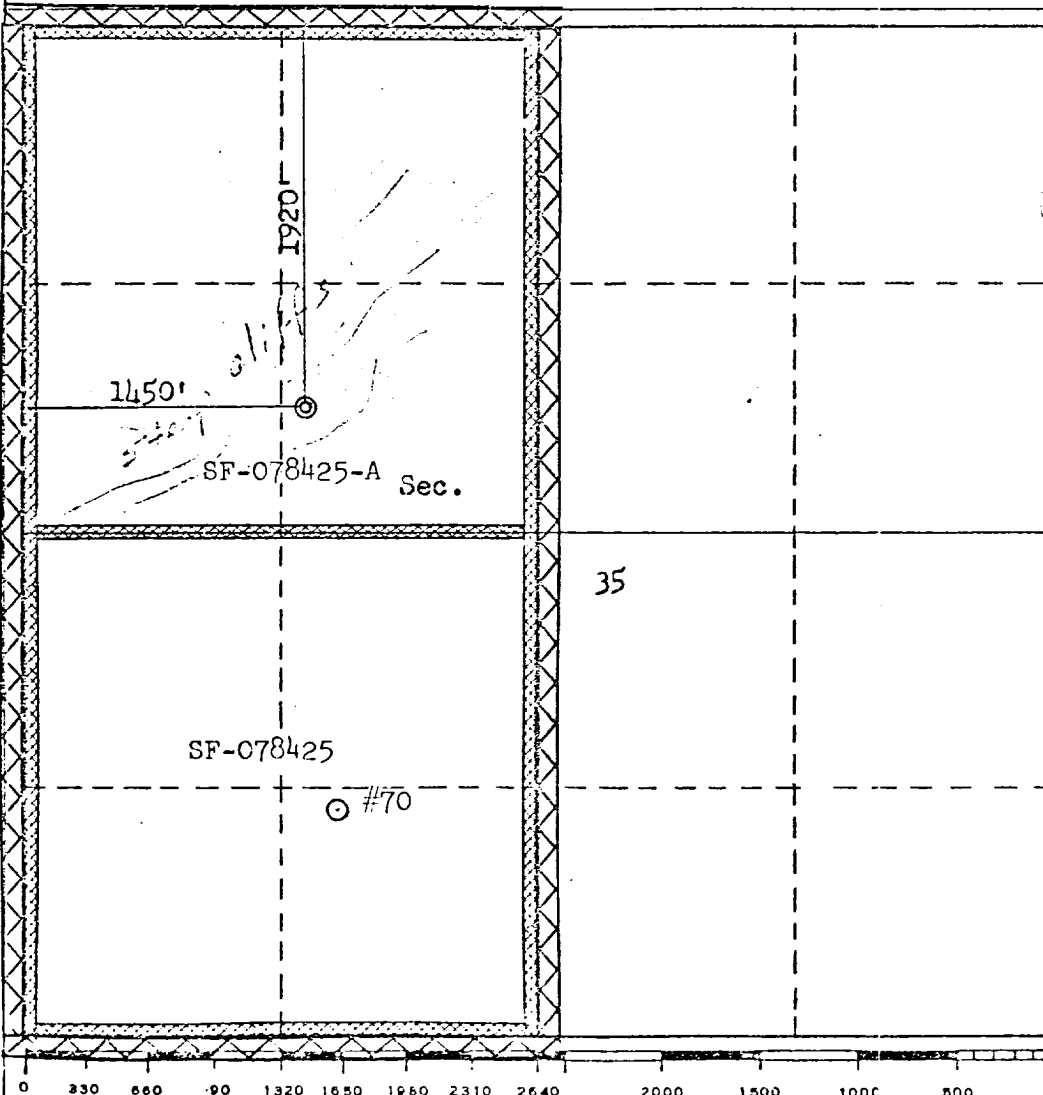

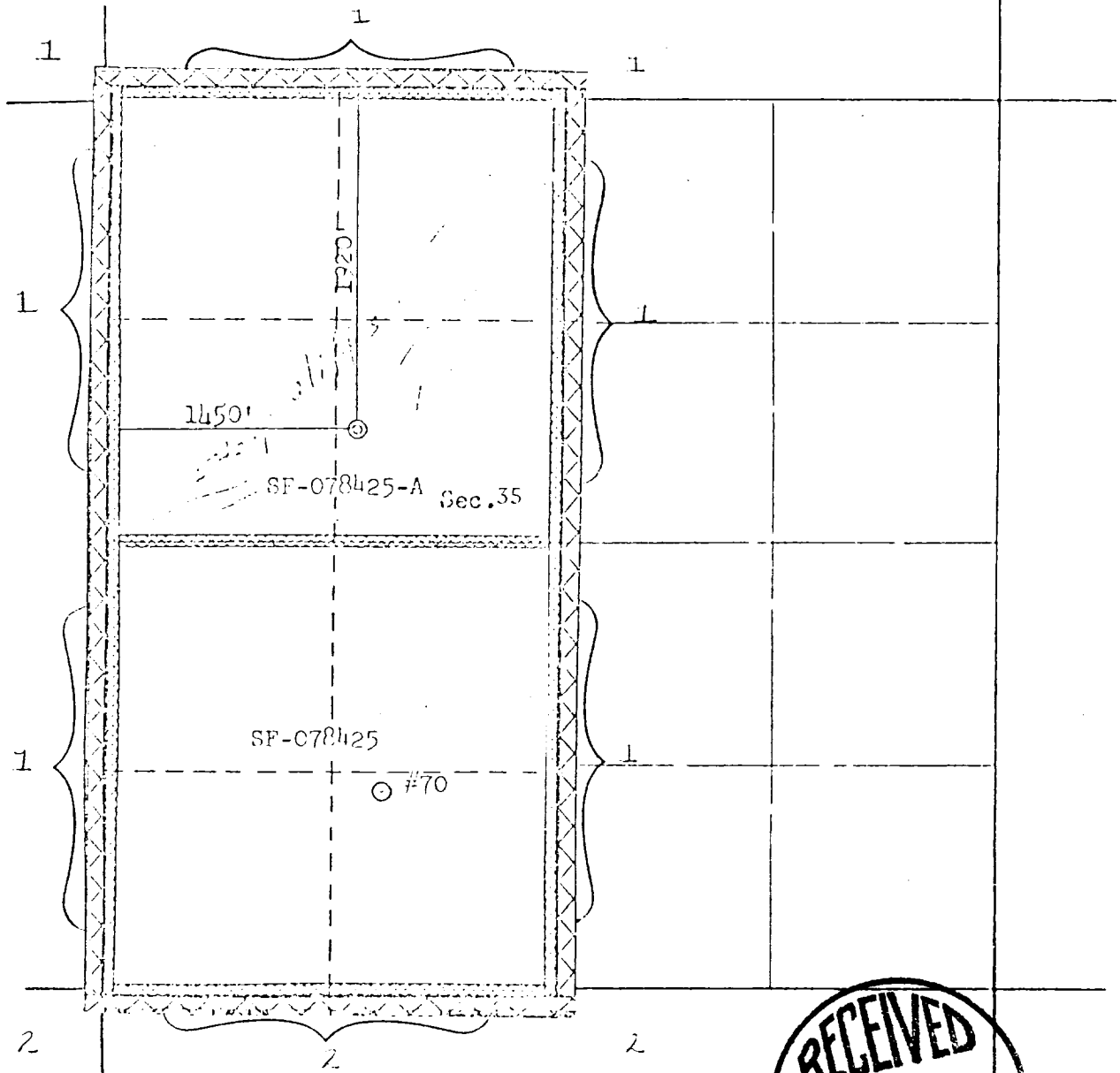
