Class "B", with 1/4# gel flake/sk, 3% calcium chloride, (295 cu.ft.). Followed by 100 class B sks, 1/4# gel flake/sk, 3% calcium chloride (118 cu ft). Circulated to surface. WOC 12 hours. Tested 600#/30 minutes, held ok.
