Burlington Resources respectfully requests a three-year shut-in extension for the subject well. As is generally known, our company is in the process of evaluating and working towards the changing of the pool rules to allow for infilling of the Fruitland Coal. We feel this wellbore represents a prime candidate for a future Fruitland Coal infill, and in the process would prevent waste by allowing us to recompleat this wellbore rather than drilling another one with additional surface disturbance. In a effort to be conscientious operators, we have taken successive casing and tubing pressures on the subject well. The tubing pressure remained at zero while the casing pressure ranged from 752-754 psi. Since the pressures are virtually identical, it is reasonable and prudent to believe it is not necessary to test for casing integrity at this time. We additionally propose to monitor these same readings over the shut-in time period in order to assure the situation does not change. Three years would allow Burlington to continue to work through the hearing process for infill approval, get budget approval for a recompleat, and perform the work.
