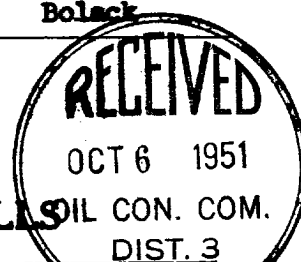

DETAILS OF WORK

7 " at 5315' with 300 sacks cement.

S/2 Section 18 is dedicated to this well.
