On 5-22-70 cut stuck tubing off at 5168', pulled tubing and set cement retainer at 4964', squeezed open hole w/ 150 sacks of cement. Perforated squeeze hole at 2583', set cement retainer at 2576', squeezed through perf. w/ 125 sacks of cement.

On 5-26-70 T.D. 5880', ran 184 joints 4 1/2", 10.5#, K=55 casing (5879') set at 5880' w/ 125 sacks of cement. W.O.C. 18 hours.

On 5-27-70 P.B.T.D. 5838'. Perf. 5838-44', 5356-68', 5684-96', 5708-14', 5736-48', 5783-87' w/ 16 SPZ. Frac w/ 70,000# 20/40 sand, 55,860 gal. water. Dropped 5 sets of 16 balls, flushed w/ 4956 gal. water. Set bridge plug and tested O. K. Perf. 5176-82', 5208-20', 5242-48' w/ 16 SPZ. Frac w/ 40,000# 20/40 sand, 32,730 gal. water. Dropped 2 sets of 16 balls, flushed w/ 3528 gal. water.

Instructions
