THE APPLICATION OF PUBCO PETROLEUM CORPORATION FOR PERMISSION TO EFFECT DUAL COMPLETION OF ITS STATE WELL NO. 3, LOCATED IN THE SE/4 NE/4 OF SECTION 32, TOWNSHIP 29 NORTH, RANGE 8 WEST, NMPM, SAN JUAN COUNTY, NEW MEXICO, IN SUCH A MANNER AS TO PERMIT THE PRODUCTION OF GAS FROM THE PICTURED CLIFFS FORMATION ADJACENT TO THE AZTEC-PICTURED CLIFFS POOL AND THE PRODUCTION OF GAS FROM THE BLANCO MESAVERDE POOL.

## ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 112-A (c) Pubco Petroleum Corporation made application to the New Mexico Oil Conservation Commission on July 31, 1959, for permission to dually complete its State Well No. 3, located in the SE/4 NE/4 of Section 32, Township 29 North, Range 8 West, NMPM, San Juan County, New Mexico, in such a manner as to permit the production of gas from the Pictured Cliffs formation adjacent to the Aztec-Pictured Cliffs Pool and the production of gas from the Blanco-Mesaverde Pool.

Now, on this 18th day of August, 1959, the Secretary-Director finds:

- (l) That application has been duly filed under the provisions of Sub-section 'c' of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

## IT IS THEREFORE ORDERED:

That the applicant herein, Pubco Petroleum Corporation, be and the same is hereby authorized to dually complete its State Well No. 3, located in the SE/4 NE/4 of Section 32, Township 29 North, Range 8 West, NMPM, San Juan County, New Mexico, in such a manner as to permit the production of gas from the Pictured Cliffs formation adjacent to the Aztec-Pictured Cliffs Pool and the production of gas from the Blanco-Mesaverde Pool, through parallel strings of tubing.

PROVIDED HOWEVER, That applicant shall complete, operate, and produce said well in accordance with the provisions of Section V, Rule 112-A.
