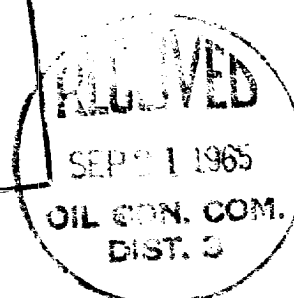
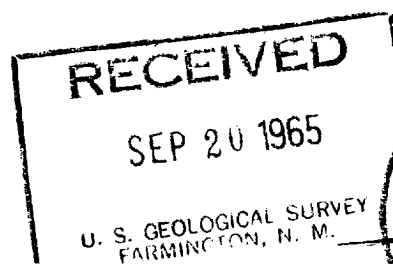

On 9-9-65 cut casing at 4630', set packer at 4419', squeezed open hole w/200 sacks regular cement, 1/4 cu. ft. Coalite/sk., followed by 100 sacks regular cement w/10% sand, 2% calcium chloride, final squeeze pressure 1000%. Perf. 2 squeeze holes at 2044', set retainer at 1914', squeezed w/100 sacks regular cement, 2% calcium chloride, final pressure 500%.

On 9-10-65 set retainer at 1895', re-squeezed perfs at 2044' w/125 sacks regular cement, 3% calcium chloride, final pressure 1500%, held 1300%.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
