This well has been plugged and abandoned as follows:

The uncemented liner (4490-5275') and open hole (5275-5347') were squeezed thru a cement retainer set at 4437' w/400 sacks of cement during a workover attempt.

Spotted a 10 sack cement plug at the base of the Ojo Alamo inside casing at 2150'.

Shot 7" casing off at 706', pulled casing. Ran tubing to 706' and spotted a 50 sack cement plug over casing stub at 706'.

Spotted a 25 sack cement plug at the base of surface casing.

Placed a 15 sack cement plug at surface w/a 4' x 4" P & A marker.

P&A completed on 10-23-69.
