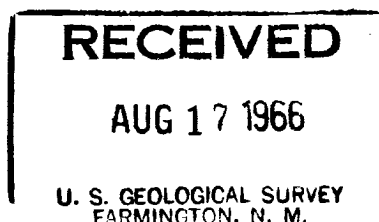

Dropped last of 16 balls, pressure went to 4000# when balls hit. Could not release balls or breakdown formation w/4500#. Cleaned out sand to 5442'. Pressured to 3500# on sand bridge. Perf. Point Lookout 5328-40, 5352-56, 5367-72, 5381-5403, 5414-22 w/16 shots/zones. Frac w/50,000# 20/40 sand, 51,310 gallons water w/2# FR-8/1000 gallons. Max pr 2800#, BDP vacuum, tr pr 1700-2000-2100-2300-2800#. IR 54.4 BPM Dropped 4 sets of 16 balls each, flush w/4100 gallon water. ISIP zero, 5 min SIP zero. Set BP at 5100#, tested w/3500#, Perf. Cliff House 4730-42, 4760-72, 4787-98 w/18 shots/zones. Frac w/24,000# 20/40 sand, 23,870 gallons water w/2# FR-8/1000 gallon. max pr 2700#, BDP 1700#, tr pr 2000-2400-2600#. IR 48 BPM. Dropped 2 sets of 16 balls each, flushed w/3480 gallons water. ISIP 600#, 5 min SIP 250#.
