Well will be drilled with rotary tools to top of Cliff House, 7" production string set and cemented, and pay sands drilled with rotary using natural gas method to a total depth of approximately 5525'.

Well will be shot with approximately 1800 quarts of nitro glycerine

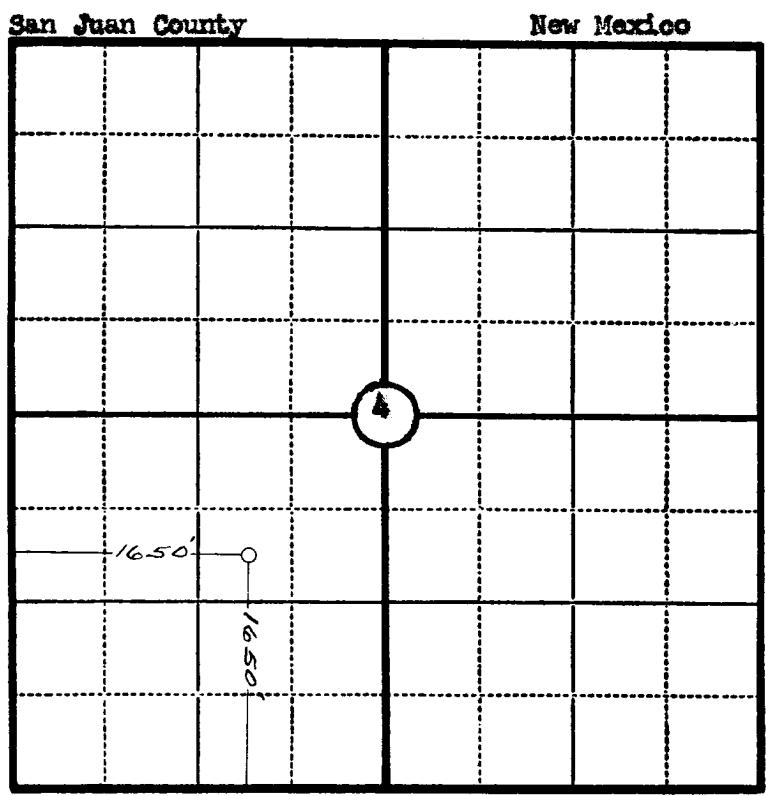
