On February 10, 2000, Amoco Production Company submitted for your approval Notice of Intent to plug and abandon the subject well. Approval was granted March 13, 2000. On July 26, 2000, Amoco submitted an amended NOI requesting a change in the previously approved plugging procedure. This request was approved on August 7, 2000. This is to advise as of this date the plug and abandonment process has not been initiated. It is our intent to first make an attempt to restore the well to production within the 3rd Qtr of this year. If this attempt proves unsuccessful then we will procede to plug and abandon the well as per the NOI submitted on July 26, 2000. We therefore request an extention to the original plugging NOI in order to allow for an attempt to be made to restore the well to production.
