The subject well was previously approved for plug and abandonment on August 7, 2000. A Sundry request was filed on 05/09/2001 requesting permission to delay the plug and abandonment pending an attempt to restore the well to production within the 3rd Qtr of 2001. The proposed activity was not initiated within that time frame and a Sundry request was submitted on 01/02/2002 requesting additional time to further evaluate and attempt production restoration. The result of that evaluation and review indicates that there is no future recovery potential for the subject well, therefore, a decision has been made to proceed with permanent plug and abandonment of the well in lieu of temporary abandonment as per discussion with Steve Mason (BLM) on 04/29/2002. We respectfully request permission to plug and abandon the subject well as per approval granted on 08/07/2000. The subject well has been placed on our plug and abandonment rig schedule for plugging, however, due to wells previously scheduled for plug and abandonment we anticipate that the plugging of the subject well to begin on or prior to 07/03/2002.
