11-29-72 PBTD 3227'. Perf'd 3138-46' and 3156-72' with 24 shots per zone. Frac'd with 30,000# 10/20 sand and 31,880 gallons treated water. Dropped one set of 24 balls. Flushed with 800 gallons.
