Production liner will be set through the Mesaverde pay zone and perforated; then, perforate the 7" csg. and dually completed in the Pictured Cliffs formation. The pay zones will be isolated by utilizing a production packer. All work will be conducted in accordance with rules and regulations of the State of New Mexico.

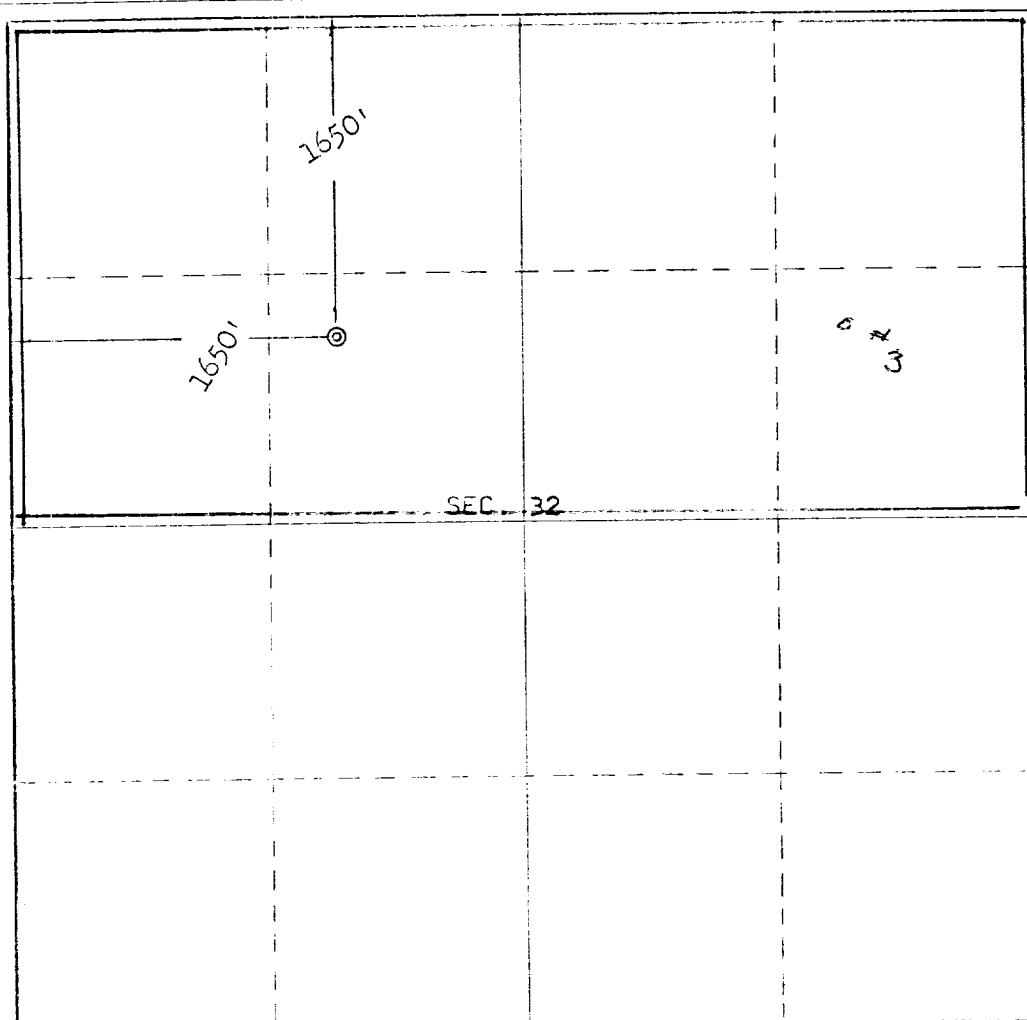
