MIRUSU, Pump 20BBIs 2% KCL down 2 3/8" TBG & 20 BBIs down backside. Kill well. TOH with 2 3/8" TBG, hole is 1st jnt above seal assembly. Seals damaged, haul to town to be redressed. Tubetest all 2 3/8" TBG to 3000psi OK. Run in hole as follows: 1- Bullnose, 1 jnt 2 3/8" TBG, 1 perforated sub, 1 baker f nipple, 77 jnts 2 3/8" tbg with shaved collars, 1 locator seal assem, 99 jts. 2 3/8" TBG. Sting into packer & space out. land tbg in donut. Chg rams to 1 1/4" tbg as follows: 1 bull nose, 1 jnt 1 1/4" tbg, 1 perforated sub, 1 SN, 93 jnts 1 1/4" tbg. Land shortstring. NDBOPS, NUWH. Rig in slickline unit. make 2 runs to pull baker plug OK. 2 3/8" TBG BTM @ 5515', 1 1/4" TBG BTM @ 3042'. RDMOSU.
