Spudded 13 3/4" hole on 4/30/79. Drilled to 236', ran 5 jts 9 5/8", 36#, K-55 csg and set @ 230'. Cemented w/160 Sx class "B" cement, 1/4# Sx flocele. Woc 12 hrs. Pressure tstd BOE to 600 psi for 30 min-held ok. Reduced hole to 8 3/4" and drilled to 3700'. Ran 86 jts 7", 23#, K-55 csg and set @ 3689'. Cemented w/665 Sx BJ poz, 4% gel, 6 1/4# Sx Gilsonite, 1/4# Sx Flocele, followed by 150 Sx class "B" neat cement w/2% CACL2. WOC 12 hrs. Pressure tstd csg to 600 psi for 30 min-held ok. Reduced hole to 6 1/4" and drilled to T.D. @ 7929' on 5/11/79. Ran electric logs. Ran 107 jts 4 1/2", 10.5#, K-55 csg w/liner and set @ 7929' w/top of liner @ 3531'. Cemented w/510 Sx 50/50 poz mix, 4% gel, 6 1/4# Sx Gilsonite, 1/4# Sx Celloflake, .6% D-19, followed by 100 Sx Class "B" neat cement w/.6% D-19. WOC 12 hrs. Released rig. WOCU.
