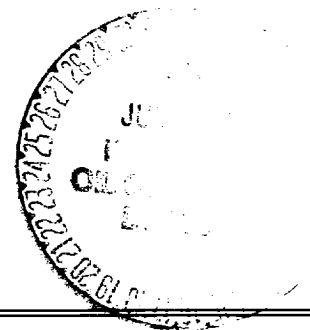

Please reference telephone conversation on May 17, 2002, between representatives of BP America and Steve Mason, BLM and Charlie Perrin, NMOCD, regarding bringing various inactive wells into compliance.

The subject well was approved for fracture stimulation on 01/29/2002. Verbal permission was granted to temporarily abandon the well (i.e. se: CIBP, pressure test for casing integrity, & leave CIBP in place) in order to bring well into compliance and hold until such time that the previously approved stimulation process could be performed. If the casing integrity test fails we will cease operations and obtain approval to plug and abandonment. If the results of the fracture stimulation fail to restore the wellbore to production status, we will proceed to file for permission to plug and abandon.
