After further review a decision has been made to permanently abandon the wellbore. Well is currently plugged back to 184'. Calculations are being made to determine amount of cement to utilize in properly plugging the well to the surface. Upon determination, procedure to P&A will be forwarded to your office. This should be around the 27th of this month as I will be out of the office until that date.
