Tailed w/ 90 sx Class "B" 50/50 poz w/2% sodium metasilicate, 2% calcium chloride, 0.25 pps cellophane, 5 pps kolite (157 cu ft). Circ 5 bbl cmt to surface. WOC. NU BOP.
