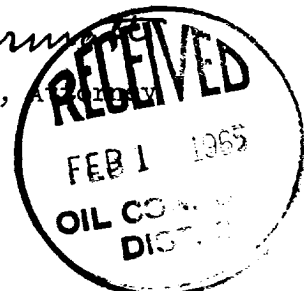

In order to comply with the enclosed order of the New Mexico Oil Conservation Commission, to repair or plug the captioned well, Southern Union Production Company, as Operator and pursuant to Section VIII of the Operating Agreement covering operations on the said well, hereby gives notice of its intention to plug the said well in accordance with a Commission approved plan of plugging operation.

In order that Operator may comply with the expressed provisions of the order, requiring all operations to be completed within 60 days from the date of said order, Southern Union Production Company requests that you immediately indicate your approval to plug the said well in the space provided below, thereby waiving the 10 days notice provision provided in said Section VIII. If you do not agree to such plugging, please notify Southern Union Production Company of your election to purchase its interest in the said well, also as provided in Section VIII.
