DETAILS OF WORK

We propose to workover the above well as follows:

1. Move in and rig up workover rig.
2. Cleanout hole with gas to total depth, or whipstock hole, if necessary.
3. Run 5" liner to total depth and cement.
4. Drill out cement and perforate selected zones.
5. Stimulate with sand-water frac.
