On January 11, 1960 4-1/2" liner was set from 2171' to 4402' with Baash Ross Lead Seal packoff type hanger. Cemented with 275 sacks 6% gel with 2 lbs. Tuf Plug per sack. Squeezed top of liner with 100 sacks cement containing 2% calcium chloride. After waiting on cement tested liner with 3000 pounds psi for 30 minutes with no indicated drop in pressure. Completion operations were begun.
