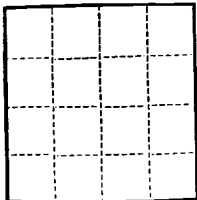

**DETAILS OF WORK**

1. Move in and rig up workover rig.
2. Cleanout hole with gas to total depth, or whipstock hole, if necessary.

4. Drill out cement and perforate selected zones.
5. Stimulate with sand-water frac.
