This Form filed in accordance with instructions in Mr. Emory C. Arnold's letter of 7/7/55, to qualify for an increase in allowable.

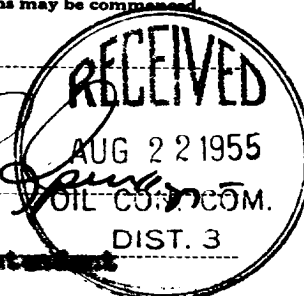
