Likins Gas Unit "C" Well No. 1. On February 20, 1959, 4-1/2" casing was set at 2369' with 650 sacks 6% gel cement with 2 pounds Tuf-Plug per sack, followed by 50 sacks neat cement. Released rotary rig on February 20, 1959. Moved in completion unit on February 24, 1959 and tested casing and water shut-off with 3000 pounds pressure, which held with no drop in pressure.
