11-19-74 the subject well was acidized over interval 2428-2474' with 1000 gallons 20% HCl and 10 gallons Aectie Anhydrite and 100 pounds Citric Acid. Maximum treating pressure 830 psi. AIR 2 BPM. Pressure dropped to 350 psi, then to 0 and on vacuum during acid job. Shut in well 14 hours. Landed tubing at 2457', hooked up wellhead, and returned well to sales line. Production before acid job 32 MCFD, after 60 MCFD.
