Repair operations commenced on 4-15-81. Total depth of the well is 3100' and the plugback depth is 3065'. There were no perforated intervals during the repair operations. Fraced the formation with 40,000 gallons of foam and 72,000 pounds of 10-20 sand. Landed 1 1/4" tubing at 3019'. Released the rig on 4-21-81.
