On May 11, 1955, 5-1/2" casing was landed at 4284 feet and was cemented with 175 sacks cement. After waiting on cement 36 hours, the casing and water shut-off were tested with 1200 pounds pressure for 30 minutes with no drop in pressure. Drilling operations were resumed.
