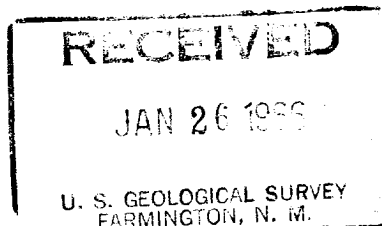

Instructions

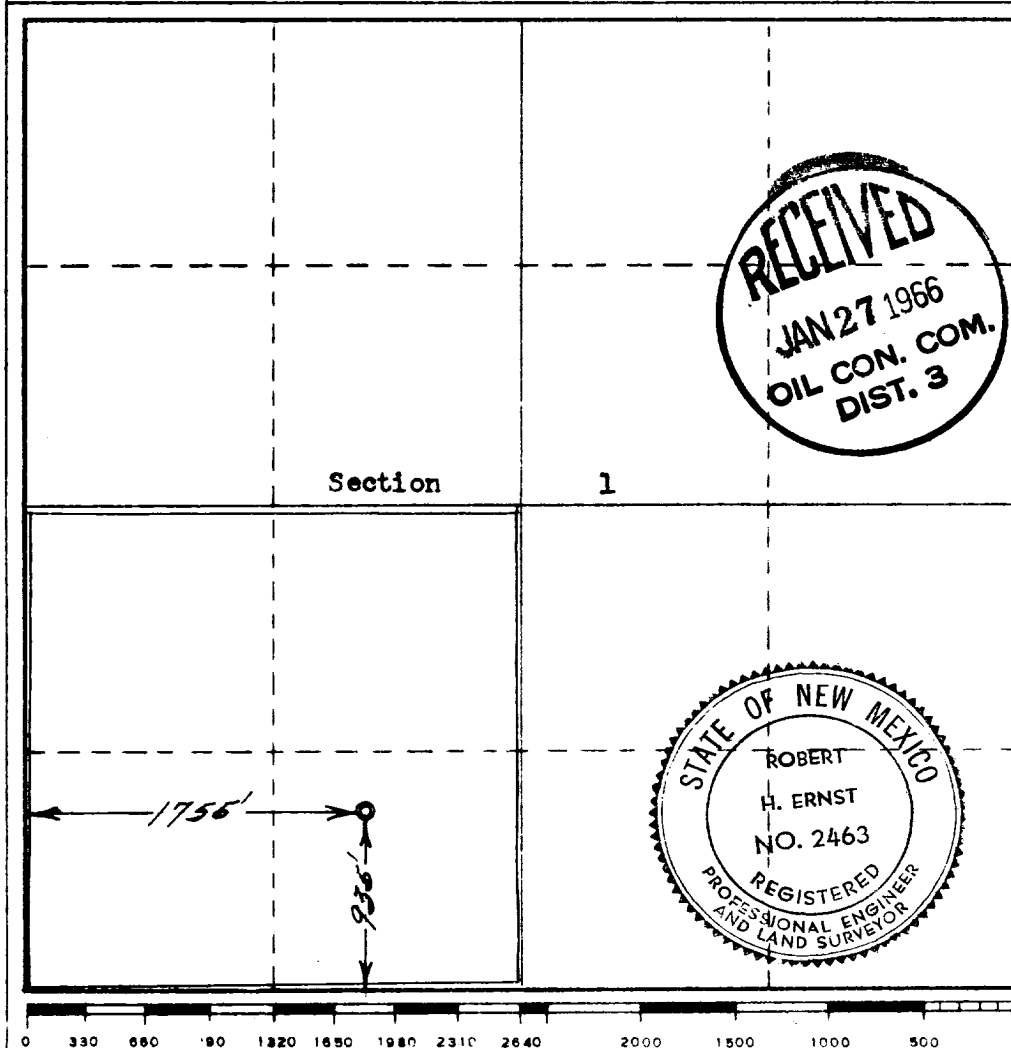
