DETAILS OF WORK

It is intended to drill a well with rotary tools through the Mesaverde section, drilling the pay section with gas circulation. Also, to shoot the entire Mesaverde with approximately two quarts of S.N.G. per foot. T.D. 5500'.

Casing Program as Follows:

9-5/8" at 150' with cement circulated to surface.

7 " at 4580' with 300 sacks regular cement.
