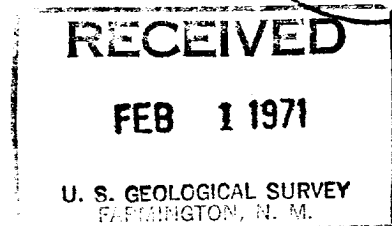
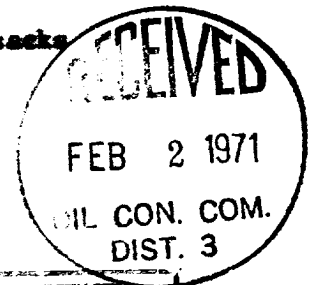

Due to the failure of the Lobato Gas Con "C" No. 1 to produce commercial quantities of hydrocarbons, we abandoned the well as follows:

- 1. Pumped 10 sacks Type "A" cement with 2X Floccals and 100 sacks Type "A" cement down casing.**
- 2. Pumped 50 sacks Type "A" cement down annulus.**
- 3. Set FXA marker and cleaned up location.**

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
