The 12-1/4" hole was reduced to 6-3/4" at 211' and drilled to a total depth of 2085'. The 2-7/8" casing was set at 2075' with 500 sacks Type "C" 50-50 Pozmix with 2% Gel and 2 pounds Tuf Plug followed with 100 sacks Neat cement. The cement circulated. Spotted 100 gallons 10% Acetic Acid and shut in the well.
