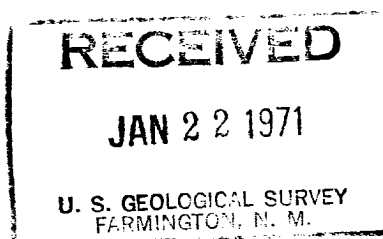

On 12-19-70 spudded well, drilled surface hole and ran 7 joints 8 5/8", 24#, J-55 surface casing (226') set at 239' w/175 sacks of cement circulated to surface. W.O.C. 12 hours. Held 600#/30 Min.

On 12-21-70 Total depth 2184', ran 70 joints 2 7/8", 6.5#, J-55 production casing (2172') set at 2184' w/220 sacks of cement. W.O.C. until completion.

On 12-28-70 P.B.T.D. 2154', perf. Pictured Cliffs 2018-26', 2044-60' w/32 SFZ. Frac w/26,000 gal. water, 26,000# 10/20 sand, flushed w/427K gal water, dropped 1 set of 32 balls.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
