On December 28, 1972, the well was perforated 2084-2128' with 1 JSPP. Spotted 500 gallons 15% HCl across the perfs and displaced. Breakdown pressure 1100 psi. Sand-water fraced with 35,000 gallons treated water (1% KCl and 10 pounds Cal per 1,000 gallons water), 5,000 pounds 20-40, 20,000 pounds 10-20, and 10,000 pounds 8-12 sand. Treating pressures: Maximum 2100 psi, average 1900 psi. AIR 48 BPH.
