We have completed the pressure test on the subject well as follows:
MIRU workover rig. POOH with 1-1/4" tubing. RIH & set retrievable bridge plug at 2420'. Loaded hole with 2% KCL. Pressure tested casing to 580 psi. Pressure test held OK. Retrieve bridge plug. RIH with 1-1/4" tubing & land tubing at 2544'. RDMO workover rig.
