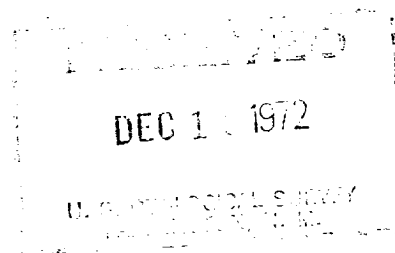
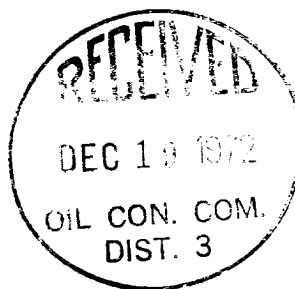

On December 9, 1972, perforated 2110-34 with 1 jet SPV and spotted 500 gallons 15% HCl and displaced. Breakdown pressure 1700 psi. December 18, 1972, sand-water fraced with 15,000 gallons treated water (1% HCl and 10% Cal per 1000 Gal. water), 5000 pounds 20-40, 20,000 pounds 10-20 and 10,000 pounds 8-12 sand. Treating Pressures: Maximum 2000 psi, minimum 1500 psi, average 1700 psi. AIR 49 BPM.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
