A 12-1/4" surface hole was spudded on November 16, 1972, and on November 17, 1972, 8-5/8" casing was set at 218' with 200 sacks Class "A" cement with 2% CaCl₂. The cement circulated.

On November 19, 1972, 4-1/2" casing was set at 2301' with 300 sacks Class "C" 50-50 Pozmix with 6% gel and 2 pounds Tuf Plug per sack followed by 75 sacks Class "C" Heat. Did not circulate.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
